Telemedicine Policy Issued April 29, 2022

- Permanent
- Extended for further evaluation
- Expires at end of federal public health emergency (PHE)



Telemedicine Policy - Permanent

- Patient home as referring site (waiving referring site restrictions) for E/M codes
 - 99202 99204
 - 99212 99214
- All encounters that include both audio and visual components must include sufficient quality and/or resolution and include privacy protections
- Continued use of GT modifier when services are rendered via telehealth



Telemedicine Policy -

Extended for Further Evaluation

Extended for one year post-PHE for further evaluation:

- SCDHHS will continue to reimburse FQHC and RHC for telehealth services (See Medicaid bulletin for specific codes)
- When audio/visual telephonic services are not available, SCDHHS will reimburse for audio-only with specific CPT codes
- Behavioral health services by LIPs and associate-level licensed practitioners (including psychiatric diagnostic and evaluation, individual psychotherapy and family psychotherapy)
- Well-child care and EPSDT visit (99381-99385 and 99392-99395)



Telemedicine Policy – Expiring

Will expire at the end of the current PHE:

- Occupational therapy
- Behavior modification
- Psychosocial rehabilitation services (individual and family support)



Coverage Groups

Maternal Health and Postpartum Coverage

 Postpartum coverage for Medicaid-eligible pregnant women was extended from 60 days to 12 months (effective April 22, 2022)






Behavioral Health Redesign and Policy

- SCDHHS's contractor, Mercer, held stakeholder interviews and drafted a gap analysis of mental health services Project Goals:
 - Increase access to mental health services in schools
 - Increase network capacity
 - Increase quality of care
- Pediatric focus group was held April 14 and May 17
- July 1, 2022: Updates were made to the school-based mental health policy with the goal of improving access to school-based mental health services



Fluoride Varnish (FV) in a Non-Dental Setting*

AT A GLANCE...

- A **1,481% of increase** in the number of Medicaid children receiving FV in a non-dental setting has been noted since 2011
 - 7.5 % decrease between 2019 and 2021
- CY2021 data reflects:
 - ~ 74% of the children were between 0 4 years old
 - ~ 21% were 5 12 years old

*Data based on Medicaid administrative claims through CY 2021; excludes FQHC

2018	 Expanded coverage for all children ages 021 years (from the eruption of first tooth) can receive fluoride varnish during well visits or sick visits. Increased frequency for FV varnish application: Ages 0 - 6 may receive a maximum of 4 applications/year; 7-21 year olds may receive 1 application/year (2 month/365 days) Integrate oral screening during each EPSDT/well checkup visit. (periodicity schedule included) 	

Healthy Connections

Developmental and Mental Health Screening

AT A GLANCE...

- 414% increase in the number of children 18 years old or under receiving a developmental screening since 2011
 13.7% increase since 2019
- **511% increase** in the number of children receiving an emotional/behavioral health screening since 2015
 - 15.2% increase in 2019
- **1,750% increase** since 2011 in environmental and risk assessments
 - 5.8% increase since 2019



HEDIS-like Administrative Claims Data - 2021






WCC: Child and Adolescents








Percentage of Medicaid Beneficiaries Ages 1 to 20 Who Received Preventive Dental Services, FFY 2020



Other notable accomplishments:

- Chlamydia screening for 16–20-year-olds: QTIP remains above national benchmarks (50th percentile)
- ADHD initiation AND continuation: QTIP practices are above the 75th national benchmark






HEDIS-like Administrative Claims Data



Nutrition and Counseling for Physical Activity






2021 Vaccine Data Reflecting Percentage of Medicaid Children Vaccinated by Age 2





QIDA: Quality Improvement Data Aggregator

- Standardized data
- Freedom to select what to work on
- Develop run charts, examine data and develop quality projects
- "Real time" data pulled by you (10 charts/topic)

QIDA and HEDIS data are different

QIDA can show you where you have the <u>most</u> room for the <u>most</u> improvement, and where you could benefit to take a deeper dive and initiate a QI project

QIDA is important to QTIP!




- Gives us over 300 data points per month (3,600/year)

QIDA Highlights: August 2021–May 2022

- Over the past ten months, QTIP practices' self-audits for social determinants of health (SDOH) (ages 3-6) and obesity (ages 7-10) have reflected:
- Well-child Care
 - Consistently over 92% for 3-6-year-olds
 - Consistently over 88% for 7-10-year-olds
- Vaccines
 - Consistently over 86% for 3-6-year-olds
 - Consistently over 95% for 7-10-year-olds
- SDOH Screenings
 - Among 3-6-year-olds increased 20 percentage points (36% increase)
 - Among 7-10-year-olds increased 19 percentage points (43% increase)



QIDA Highlights: August 2021 – May 2022

Over the past 10 months, QTIP practices' self-audits for SDOH (ages 3-6) and obesity (ages 7-10) have reflected:

- **SDOH:** Primary work centered around:
 - Documenting protective factors/family strengths
 - Providing SDOH resources to families +
 - Documenting Z codes
 - Trauma screenings
- **Obesity:** Primary work centered around:
 - Documenting Z codes
 - Discussing screen time and sleep hygiene
 - Physical activity counseling
 - Documenting SMART goals

Participation Agreement

Outlines QTIP Benefits/Services:

- Learning Collaboratives and workshops
- Technical assistance (site visits, monthly calls, QI coaching, support with incorporating practices' mental health efforts)
- ABP MOC Part 4

Requirements:

- Establish and maintain a quality improvement team
- Two or more QTIP team members are expected to be present for the duration of both learning collaborative sessions
- Active participation in quality improvement initiatives including documentation of the QI project/activities
 - Participation in at least one QI workshop every 24 months
- Monthly data entry into QIDA on selected topic areas
- Participation in at least one site visit per year
- Active participation with all surveys sent by QTIP staff
- Lead physicians are encouraged to act as site visit peer reviewers (at least one per year)
